I. PENALTY PROVISION

General Features of the Self Cleaning Electronic Toilet:-

- i) Structure of the toilet should be made of Stainless Steel (SS-304).
- ii) Coin Validator System.
- iii) Pre Flush, Auto Flush, Automatic platform cleaning mechanism to clean the toilet before and after usage.
- iv) LED indications to notify the user about the status of the system.
- v) Voice guidance to help the user to operate the toilet without manual assistance.
- vi) Display boards where instructions in English, Hindi will be written for the aid of the user.

- vii) In built water tank.
- viii) Advertisement panels on which public messages, corporate advertisements can be displayed.
- ix) GPRS Connectivity which will help in the monitoring the health status of the unit.

Broad Functional Description:-

The unit should have an Indian style closet, health faucet, lights, status display and instruction boards. The water tank shall be erected on top of the toilet unit. The tank shall be connected to the three flushes (preflush/platform washing/ after use flush) in the unit.
