In pursuance to the approval conveyed vide letter No T.21013/16/2013-NCD/FTS-63883 dated 01/07/2014 by Ministry of Health & Family Welfare, Government of India. and on the recommendations of the Interview Board, held on 20.03.2015, to the post of **Medical Officer (Dental)**, appointment is hereby offered on contract basis to the following candidates at the institution shown against their name to the post of Medical Officer (Dental), for the period of one year with consolidated fixed contractual amount @ of Rs.26,250/- per month:-

TERMS AND CONDITIONS

- (a) The contractual appointee will be paid fixed contractual amount Rs.26, 250/- per month. The contract appointee will be entitled for increase in contractual amount Rs.790/-(3% of minimum of the pay band+grade pay of the post) for further extended years and no other allied benefits such as senior/ selection scales etc. will be given.
- (b) The services of the contract appointee will be purely on temporary basis. The appointment is liable to be terminated in case of the performance /conduct of the contract appointee is not found satisfactory/or as National Oral Health Programme-NHM, MoHFW, GOI funds continue.
- (c) Contract appointee will be entitled for one day casual leave after putting one month service. This leave can be accumulated up to one year. No leave of any other kind is admissible to the contract appointee. He/ She will not be entitled for Medical Re-imbursement and LTC etc. Only maternity leave will be given as per Rules.
- (d) Medical Leave of 10 days shall be credited into the account of contract employee at the start of the year which can be availed at any time during the year and it may be granted on full pay.
- (e) Unauthorized absence from duty without the approval of the Controlling Officers shall automatically lead to the termination of the contract. Contract Appointee shall not be entitled for contractual amount for the period of absence from duty.
- (f) An official appointed on contract basis that have completed three years tenure at one place of posting will be eligible for transfer on need based basis wherever required on administrative grounds, subject to availability of vacancy.
- (g) Selected candidates will have to submit a certificate of his/ her fitness from a government Registered Medical Practitioner. Women candidate pregnant beyond twelve weeks will temporary unfit till the co confinement is over. The women candidate will be re-examined for the fitness from a authorized medical officer/practitioner.
- (h) Contract appointee will be entitled to TA/DA if required to go on tour in connection with his/her official duties at the same rate as applicable to regular counterpart official at the minimum of the par scale
- (i) Provision of service rules like FR SR, Leave Rules ,GPF Rules, Pension Rules & Conduct Rules etc. as are applicable in case of regular employees will not be applicable in case of contractual appointees. They will be entitled for emoluments etc. as detailed in this column.

- (j) To execute the contract/agreement between candidate and department should report for duties at the respective place of his/her posting within 15days (fifteen days) failing which the offer of appointment issue will be treated as cancelled.
- (k) The National Health Mission may terminate the employee by giving one month notice or one month remuneration in lieu there-off with immediate effect.
- (I) No TA/DA will be allowed for joining of duty.
- (m) If the appointee accept the offer of appointment on the above terms and conditions, he/she after been declared as medically fit by the CMO concerned.
- (n) The contract appointees are not entitled for regulisation in NHM.
- (o) The appointment is further subject to the production of following certificates to the concern office in charge of the institution where he/she will join:-
 - 1. Matriculation certificate or other equivalent certificate showing your date of birth.
 - BDS Degree.
 - 3. 1st to 4th year BDS Mark sheet.
 - 4. Internship Completion Certificate.
 - 5. HP State Dental Council Registration Certificate valid up to Dec 2015.
 - Latest Character Certificate from a Gazetted Officer of Govt/Semi Govt Organization/Head of Institution last attended.
 - No Objection Certificate from your present employer (if any).
 - 8. Experience Certificate.
 - 9. Attempt Certificate by college authorities (BDS).
 - 10. Himachali Bonafide Certificate.
 - 11. Proof of Residence (Ration Card/Aadhar Card/Voter Card/Driving License/Passport/Utility Bill etc.
 - 12. Two recent photographs duly attested by the same authority who attested your certificates.

2.	The pay of first party will be Rs 26,250/- only (for BDS) P.M. for a period of one year in lump-sum.				

- The National Health Mission may terminate the employee by giving one month notice or one month remuneration in lieu there-off with immediate effect.
- The appointment shall be subject to medical fitness from Medical Board constituted by the Govt. of HP for this purpose at Zonal and Distt Hospitals.
- 5. Private practice of any kind by the first party in any manner is prohibited.
- 6. The appointment will not confer any right continuation and confirmation etc.
- If the FIRST PARTY commits any kind of misconduct in that event the SECOND PARTY will be competent to terminate this agreement after holding enquiry. On such termination the FIRST PARTY shall not be entitled to any compensation whatsoever.
- 8. The contractual appointee will not be eligible for regulization.



- The FIRST PARTY shall be entitled to get one casual leave for every completed month of service. No leave of any kind is admissible to the contractual appointee(s). He/she will not be entitled for Medical Reimbursement and LTC etc. Only maternity leave will be given as per Rules.
- 10. Before joining the service, the FIRST PARTY shall submit the following documents:-
 - Certificate of medical fitness issued by the Medical Board constituted by the Government for this purpose At Zonal /Distt. Hospitals.
 - ii) A declaration to the effect that the appointee(s) has not/shall not more than one spouse or shall not marry a person who have a living spouse;
 - An oath of allegiance faithfulness to the constitution of India for making a solemn affirmation to that effect;
 - iv) The appointee(s) shall have to produce the following certificates at the time of his/her joining the duties:-
 - a) Degree/Diploma Certificate of educational and other professional qualification;
 - b) Certificate of age proof along with the copy of Matriculation certificate passed from the recognized Board/University;
- 11. During the period of contract, in case the MO(Dental) has to undertake training due to official work, he/she will be entitled for TA/DA at par with regular counterparts at minimum of pay scale.
- 12. NO TA/DA will be paid to the FIRST PARTY for joining the contract service.
- 13. The offer of appointment on contract basis is specifically valid for the station of his/her posting shown in the letter. He/she shall not be transferable to any station up to a period of 3 years from the date of joining in the event of extension of contractual period on year to year basis.
- 14. The above terms and conditions will be applicable in all contractual appointments of Medical Officer (Dental).
- 15. They will be given fixed annual increment of Rs.790/-.
