

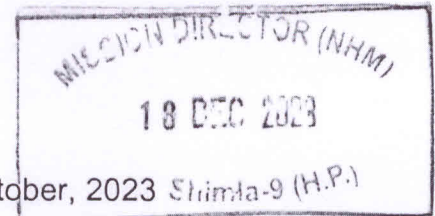

Subject: Regarding Performance Linked Incentives for 1st indicator - clarification thereof

Sir/Madam,

In reference to the subject cited above, it is informed that we are in receipt of queries from some districts regarding verification of the incentive data from the RCH portal for PLI indicator no. 1 i.e. **"Proportion of newborns who received HBNC services by CHO/MPW/ASHAs against the number of newborns who received 6 HBNC visits in case of Institutional Delivery and 7 HBNC visits in case of Home Delivery as per HBNC under Child health Programme"** notified via Notification No. NHMHP-HWC0PBI/1/2019-HWC-Section- Part (1)-6339 dated 4.6.2022 under AB-HWC program.

In this regard it is hereby clarified that,

1. ANMs/ HWs and ASHAs have already been registered and mapped with respective sub-centres in RCH Portal. At the time of data entry of PNC / HBNC visits , there is provision of selection of ANM & ASHA who have provided PNC/HBNC services to the beneficiaries (mothers & infants) and the same can be tracked either from data entry module of RCH Portal, ANMOL App or from the RCH Dashboard Reports.
2. Every MIS operator at district and block levels have a login ID for the RCH portal and they can cross-verify the data submitted by the field functionaries.
3. In addition to this, CHOs have been given the access to RCH portal.

Accordingly, incentives may be disbursed to the ASHAs as per guidelines notified vide this office letter No. NHMHP-HWC0PBI/1/2019-HWC-Section-Part(1)-63399 dated 4.6.2022 .
