Sir,

This is in reference to your email dated 22nd February, 2019 on the subject cited above.

It is hereby clarified that incentive of JSY can only be given to beneficiaries delivered in private institution duly accredited by National Health Mission. Keeping in view that no private Health Institution has been accredited by National Health Mission, Himachal Pradesh, any beneficiary delivering in private Health Institution within or outside the state is **Not** eligible for incentives under JSY.
