Subject: Guidelines for implementation of scheme for provision of free Insulin Pumps to patients suffering from Type-I diabetes.

Madam/ Sir,

In supersession of all previous guidelines issued vide this office letter of even no. 9553, 10889 & 11376 dated 31.05.2023, 13.09.2023 and 19.10.2023 regarding the subject cited above, the revised guidelines in respect of provision of free insulin pumps to the patients suffering from Type-I diabetes in the state of Himachal Pradesh is as under:-

1. Insulin pumps will be provided only to Bonafide residents of Himachal Pradesh.
2. The pumps will be provided to all eligible beneficiaries, including boys, girls, children, suffering from Type-I diabetes, up to the age of 27 years.
3. The pumps will be provided to pregnant women of all ages.
4. Installation will be carried out through all Government Medical Colleges in Himachal Pradesh and AIIMS Bilaspur.
5. When a patient requiring an insulin-pump reports to a Medical College, the Head of Department from Medicine/Paediatrics/Endocrinology/Pediatric Endocrinology/Obstetrics & Gynaecology will:
 - Assess and verify the patient's need for an insulin pump.
 - Confirm the patient's residential status.
 - Forward the case to the Principal of the respective Medical College.

6. The Principal/Director AIIMS, Bilaspur will then recommend the case after verifying the details of the patients to the State Headquarter, National Health Mission (NHM), along with the cost per pump arrived after following all codal formalities.
7. Based on the recommendations, NHM will approve the necessary funds to the respective institution and make allocation under budget line 111 (State Specific Initiative and innovation) and the Medical College/AIIMS will book the expenditure under the mentioned budget line.
8. The concerned Institution will procure the insulin pump and provide it to the patient free of cost.
9. A provision of recurring cost subject to a maximum cost of Rs 5000 per month per pump for new and old cases (in patients who have already been installed pumps through NHM) is being made. The vouchers on account of recurring cost must be duly verified by the prescribing doctor and the expenditure may be met from the RKS. The Principal must forward the verified bill to NHM and NHM will approve the required funds and disburse the same to the concerned Medical College/AIIMS. The funds received by the Medical Colleges/AIIMS may be reimbursed to the RKS.
10. The provision of funds for Insulin pumps and recurring cost is only for FY 2025-26. In case approvals for further years is accorded by GoI, the same would be conveyed separately.
