Subject: Regarding up-gradation work of HSCs/PHCs & UPHCs into HWC.

Sir,

This is in reference to notification No.NHMHP-HWC0GEN/3/2019-HWC-Section-13144 dated 24.8.2023 whereby 543 HSCs and 27 PHCs have been notified into HWCs.

In this regard it is to inform you that the work of upgradation of the above mentioned HWCs has been given to HLL Life Care Limited. HLL has been directed that the existing building of the HSC/PHCs may be appropriately painted, branding, affixing signages and minor repair work may be conducted. It is also informed that a maximum amount of Rs. 2 lac would be sanctioned for each HWC-HSC & HWC -PHC. The district would have the liberty to assign the amount deferentially in different HSC/PHC as per the requirement but not exceeding the overall lump sum amount allocated to them.

You are also requested to ensure that the work of upgradation is completed in all the HWCs and if up-gradation of any HSC/PHC/UPHC which are not included in above mentioned notifications but still need to be upgraded ,may also be got included in the DPR. It may be ensured that minimal branding may also be done in non-government buildings of HSC/PHC/UPHC-HWCs.

HLL has been requested to conduct the gap analysis of the above mentioned HWCs within 15 days of receipt of this letter DPRs and submit the DPRs duly verified from the concerned MO I/c, BMO, DNO and CMO to the state headquarter.
