During the Meeting, it is observed that District Indemnity Sub-Committee is not scrutinizing the Failure Cases properly as per Government of India guidelines. Therefore it is requested to all districts to follow the given instructions as observed in some cases by State Committee:-

- 1. Districts are requested to follow the SOP's before the sterilization.
- 2. LMP and D&C are compulsory before the sterilization.
- All districts were requested to issue the Sterilization Certificate in time as per GOI guidelines. Further, if Patient is UPT positive after one month of laprosterilization then don't issue sterilization certificate to the patient.
- 4. The documents should be chronologically arranged before presenting the case in SFPISC as per the checklist already shared with districts.
