



Subject: Revised guidelines for hiring the Gynecologist/ Anesthetist from private sector.

Sir/Madam,

This is in continuation of our earlier letter No. HFW-H(JSY)2006-Loose dated 9th December, 2014, on the subject cited above.

It has been decided that the services of a Gynecologist/ Anesthetist can be hired from the private sector as given below:

- 1. Only if OBG specialist/ Anesthetist are not available in the Government institution, the services from private sector can be hired.
- 2. It may be ensured that the specialist hired is adequately qualified to conduct C-Section.
- 3. In case a Gynecologist is called from the private sector to attend a Obstetric complication and the Gynecologist treats the obstetric complication or delivers the woman normally, he/she would be entitled for an amount of Rs. 1500/- per case. In case, the Gynecologist from private sector conducts a Caesarian Section on the patient he/she would be entitled for an amount of Rs. 3000/- per case.
- 4. In case, the service of an Anesthetist is hire from the private sector, he/she would be entitled to Rs. 3000/- per Caesarian section.
- 5. It may be ensured that there is an absolute indication to perform C-Section and is an emergency.
- 6. The expenditure for this should be booked under JSY.
