

Subject: -Corrigendum-Reg. Guideline for financial assistant under Janani Suraksha Yojna (JSY)-amendment thereof.

Sir/Madam,

In supersession of all earlier guidelines regarding financial assistance under JSY, the guidelines for financial assistant have been revised as follows:-

- The detail of all the beneficiaries of JSY including Bank Account No. duly linked with Aadhar No. would be uploaded on RCH portal by the concerned health functionary, for eg:- Health Worker, Health Supervisor etc. well in time.
- 2. The PFMS portal will automatically verify the details of JSY beneficiary.
- 3. Any health institution where the delivery takes place would upload the outcome on the RCH portal and guide the beneficiary to contact the respective health functionaries who registered the beneficiary. The concerned health functionary would contact the block Accountant and block Data Entry Operator to facilitate the Direct Bank Transfer of the benefit to JSY beneficiary.
- 4. No health institution will make payment directly to the JSY beneficiary. The payment will only be made through the concerned block.
- 5. In case of delivery of a patient claiming to be a JSY beneficiary, who is not registered on RCH portal, the health institution may register the beneficiary on the RCH portal and fill the outcome. However, the payment to the concerned claimant will only be made by the concerned block after verifying all the details of the claimant.
- 6. In case a pregnant woman who is already registered on the RCH portal is again registered on the RCH portal by the health institution where she had delivered, it would be the responsibility of the concerned block to delete duplicate entry after completing the verification.
- All separate accounts opened in various health institutions specifically for disbursing funds
 under JSY are to be closed with immediate effect and the balance amount be transferred to
 under JSY are to be closed with immediate effect and the balance amount be transferred to
 the respective block/district NHM account by 31st December, 2017.

8. The block and district would ensure that all physical and financial data regarding JSY be uploaded/reported after proper validation.

You are directed to ensure these instructions are followed strictly in letter and spirit. Any violation of these instructions shall be viewed seriously.
