## Terms of Reference:

Block TB Forum meets twice a year. It takes decisions on appropriate local adaptation of national guidelines for National Tuberculosis Elimination Program (NTEP) and state TB elimination strategies and seeks resources beyond the budgeted resources in (NTEP) PIP. This forum specifically focuses on inter-sectoral coordination and explores the role and responsibilities of the each of the department and prepares a roadmap for action for TB elimination in the block and resolve the issues of TB survivors. Through this forum the Psychological support/ security will be insured to all TB survivors in the block. This forum also reviews the performance of different stakeholders in TB elimination. This forum also takes final decisions on procurement of goods and contractual services for TB elimination. It guides the district administration and department of Health & FW, Government of Himachal Pradesh on recruitment of regular staff to the key positions of TB control and elimination. Notice for the TB and agenda should be served at least 15 days week before the meeting by the convener with approval of Chairperson. Meeting minutes should be submitted to Member Secretary and convener of Block TB Forum.
