Regarding notification and revised guidelines of Nirog Clinics.

Sir,

This is in continuation to letter No. NHMHP-NCD0GEN/20/2019-NCD-10334 dated 16.12.2020.

It has now being decided to further establish Nirog Clnics in the following Health Institutions of the State.

- 1. RH Chamba
- 2. Deendyal Upadhyay Zonal Hospital, Shimla
- 3. DH Hamirpur attached to Dr. RKGMC
- 4. DH Nahan attached to Dr. YSPGMC
- 5. CH Rohru
- 6. RH Keylong, Lahaul & Spiti

These would be in an addition to already notified Nirog Clinics vide Notification 16.12.2020 mentioned about. The newly notified Nirog Clinics would soon be staffed by one Staff Nurse and one Data Entry Operator by NHM through outsource basis.

The working of the Nirog Clinics would now be as follows:

- The Medical Superintendent/Incharge of the Health institution will provide a room preferably near the OPDs for the Nirog Clinics.
- 2. The Nirog Clinics would be manned by one MBBS doctor who would be trained by NHM in NP-NCD Program, if not already done. The Nirog Clinic will be further manned by one Staff Nurse and one Data Entry Operator provided by NHM on outsource basis. It is mandatory that the Staff Nurse and the Data Entry Operator will remain present at all times in Nirog Clinics during the working hours of the Health Institution. They will not be assigned any other duties without approval of the Mission Director, National Health

3. All the patients who are coming to general OPD and medicine OPD must first come to the Nirog Clinic. The Medical Superintendent/Incharge would be responsible to put in such a mechanism in place.

4. The Data Entry Operator will create ABHA ID's of all the patients attending the Nirog Clinic and seed the same on the NP-NCD portal. He/She will also administrator the CBAC form to the patient electronically. Subsequently, the Medical Officer/Staff Nurse would measure the Blood Pressure and Random Blood Sugar of the patient. The Medical Officer/Staff Nurse also must screen the patients for Oral, Breast and Cervical Cancer in the Nirog Clinic itself.

5. The Medical Officer/Staff Nurse would direct the patient to the specialist OPD or general OPD as required or as the patients desired. The patient would be asked to go to ENT Specialist/Dental Surgeon/OBG Specialist/Surgeon in case any of the three cancers i.e. Oral Cancer, Breast Cancer or Cervical Cancer are suspected.

6. The patient would be advised to report back to the Nirog Clinic after visiting the OPD(s) and would be conveyed that he/she will get monthly requirement of drugs from the Nirog Clinic itself. The patients requiring Chemotherapy would be administered Chemotherapy by the Medical Officer and the patient may be admitted in the Medical ward for the same. The Medical Specialist would also oversee the administration of Chemotherapy to the patient.

7. The Staff Nurse would dispense the medicines prescribed to the patient which are available in the Health Institution. A store would be created on DVDMS by the name of Nirog Clinic and store of the Health Institution would issue drugs to the Nirog Clinic which are indented by them.

8. The Medical Officer/Staff Nurses would counsel the patient on Life Style Modification (LSM) and the importance of regular follow-up. They will also give the next date of follow-up.

 All the required data of each patient would be updated on the NP-NCD portal by the Staff Nurse/Data Entry Operator.

10. The Data Entry Operator of Nirog Clinic posted at District level Health Institution will also assist the District Programe Officers (NP-NCD) in preparing the monthly report are Form 5A and 5B.

NOTIFICATION

Due to the epidemiological transition and dual burden of diseases, there has been a special focus on NCDs prevention and control in recent years. The NPCDCS program and the HWCs are the key interventions in addition to the NCD risk reduction though awareness and regulations. The strategy of NCDs screening (mainly diabetes & HTN) has now been changed from opportunistic screening to population based strategy. ASHA worker has to fill up the risk assessment checklist /CBAC of all 30+ populations and refer the patients for screening to ANM and for further treatment to the various levels of Health Institutions. Over and above the GOI mandate of NCD screening of 30+ populations, the State of Himachal Pradesh has taken a lead to screen all individuals of 18+ age under Mukhyamantri Nirog Yojna. The guidelines for timely and adequate screening for NCDs have already been notified vide notification no. NHMHP-NCD0GEN/18/2019-NCD-NATIONAL HEALTH MISSION-HP-4911 dated 8th July 2020.

Although the State is doing well in population based NCD screening, but in order to address the increasing demand and cater to the enhanced load of patients detected after screening, a need is being felt to integrate the treatment component of all non communicable diseases and operationalise modalities for comprehensive management on a fixed day approach, at least in the leading secondary health institutions of the State. These integrated NCD clinics shall be called as Nirog clinics keeping in view the pivotal role they are going to play in decreasing the burden of NCDs and keeping the people the State healthy.

The inpatients from the Nirog clinics shall be admitted in the concerned specialty wards only.

Infrastructure and Equipments:

There will be a dedicated room/OPD and the support staff for the Nirog clinic in the concerned facility. The clinic shall be adequately branded with signages. The following equipments/infrastructure are to be provided in the Nirog Clinic:

The table, chairs, examination tables, view box etc. will be used from the existing infrastructure in the Hospital. One Desktop with Printer shall be provided for the clinic as well. The funds for the equipment and the infrastructure up-gradation including minor civil work, if required shall be spent from the funds available with National Health Mission, based on gap analysis of the institutions concerned.

Human resource:

The overall in charge of the Nirog Clinic will be the Medical Superintendent of the Hospital who will be responsible for providing the space, logistics including drugs and

consumables. He will be assisted by the DPO NCD of the concerned district for financial support under NHM. The structure of Nirog clinics will be as below:

- 1. Medical Superintendent of the Hospital overall in charge of the clinic.
- 2. Senior most specialist of the concerned specialty Co- Head.
- 3. Concerned doctor MBBS (trained in the specialty).
- Staff nurses x1 Dedicated for Nirog clinic.
- 5. DEO for data entry and reporting purposes.
- 6. Class IV or helper x 1 To assist the clinic.

10 staff nurses and 10 DEOs for the Nirog clinics shall be provided in a dedicated manner by National Health Mission. Other manpower shall be pooled by internal adjustment. A pool of MBBS doctors (initially 2 per centre) shall be trained who shall manage the clinic daily on monthly rotation basis. Such Medical Officer shall be exempt from the emergency night duty in the month he is serving the Nirog Clinic to maintain continuity of care and services.

The staff nurses will work exclusively in the Nirog clinics and will be trained in the concerned specialty by the trained Medical Officer. The staff nurse will assist the trained MO in all procedures like chemotherapy, COPD care, Palliative care, Cancer screening (Cervical, breast and oral mainly) and will attend the OPDs and ward daily from 9.30 to 4 PM. The DEOs will report all the cases to the higher authorities on the desired platforms after proper verification of the data on prescribed formats. The class IV or the helper will work in the Nirog clinic exclusively for the routine assistance and up keeping of the clinic

The dedicated HR provided for these clinics will not be detailed for any other responsibility without the permission of Mission Director, National Health Mission. However any additional work can be assigned to any of the officer or official from time to time as decided and notified by the State Headquarters.

The specialized Nirog Clinics/ specialized clinics shall be the way forward to address the anticipated demand. They shall have adequate forward and backward linkages with

the Tertiary and primary health care institutions for the referral and community based care of NCDs. They shall be instrumental in helping the state achieve the Sustainable Development Goals within the timeline.
