Instructions in view of COVID-19.

Madam/ Sir,

In continuation to this office letter of even number dated 16/03/2020, I am directed to instruct you to take following preventive steps in the wake of noval coronavirus(COVID-19):-

1. Masks and hand sanitizers may be provided to all the inmates and staff of Child Care Institutions and One Stop Centres.
2. Health conditions of the new entrant(s) in the Child Care Institutions/ One Stop Centres be monitored closely and if need be, they may be isolated/ quarantined for at least 14 days under supervision of Doctors.
3. First aid kits may be procured to all the CCIs in consultation with the nearest Government Hospitals.
4. At least 2-3 dresses may be provided to the new entrants.
5. All the staff members, specifically those who come to the CCIs/ OSCs through public transport, be directed to keep at least 2-3 dresses/ pairs of shoes in the CCIs/ OSCs and change the same everytime, in a separate changing room/ space, allotted for this purpose.
6. Outing of the children be completely restricted.
7. The hands of all the staff members/ inmates/ any other persons visitng CCIs/ OSCs in connection with the official work be sansitized at the main gate.
8. All the NGOs running Child Care Institutions may also be directed to comply with these directions strictly.

Subject: Instructions in view of COVID-19.

Madam/ Sir,

In continuation to this office order No. 14-9/2011-ICDS dated 14/03/2020 and in compliance of the instructions issued by the Additional Chief Secretary(Health) to the Government of Himachal Pradesh vide letter No. HFW-A-A(3)1/2020 dated 14/03/2020, you are directed to take following steps for enforcing social distancing and other measures to prevent transmission of the novel coronavirus (COVID-19):-

1. Entry of outsiders in Child Care Institutions and One Stop Centres be completely restricted.
2. Adequate quantity of disinfectants and cleaning agents like soap, sanitiser, phenyl etc. be procured in all the Child Care Institutions / One Stop Centres and the inmates be encouraged for regular hand washing with soap.
3. Washrooms/ toilets be cleaned regularly with cleaning agents/ disinfectants like phenyl etc.
4. Teaching/ coaching and other group activities in all the Child Care Institutions and OSCs also be suspended till 31/03/2020. However, the inmates can keep residing in the CCIs/ OSCs with all due precautions.
5. Outing of all children/ inmates from CCIs be completely restricted. However, where annual and other examinations are taking place, the children may be allowed to take the same with all due precautions.
6. If symptoms of throat soaring, fever, flu etc. are seen / developed in any child/inmate/ staff member, he/ she may be separated from other inmates/ staff members and be taken to nearest health institution immediately.
7. During this period, the inmates of CCIs, who want to go to their homes/ kith and kin may also be allowed to do so with all due precautions.
8. All the creches shall also remain closed till 31/03/2020.
9. All instructions to be issued by the Health Department/ District Administration etc. from time to time in this regard may also be followed strictly.


